



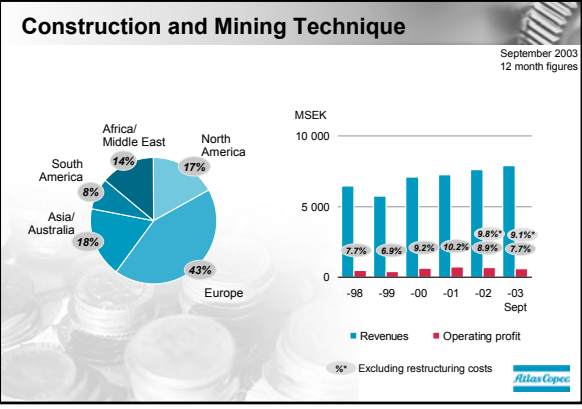

Södra länken, connecting the southern suburbs of Stockholm, is the largest road tunnel system ever built in Sweden.

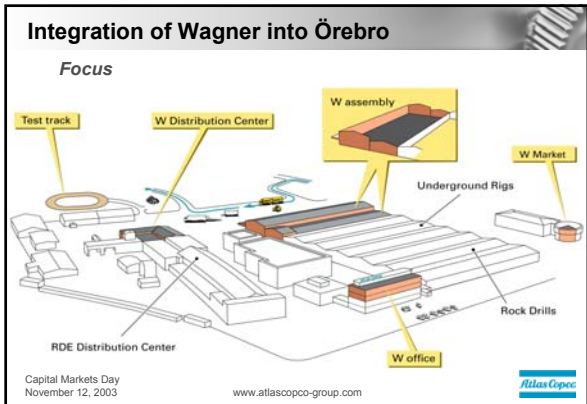

Average product age - drill rigs



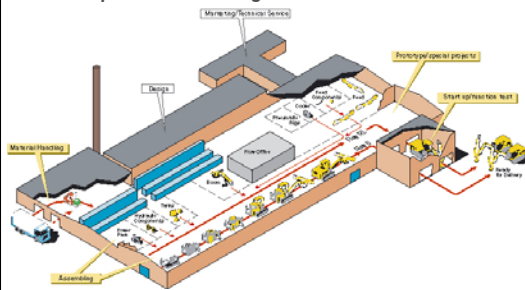

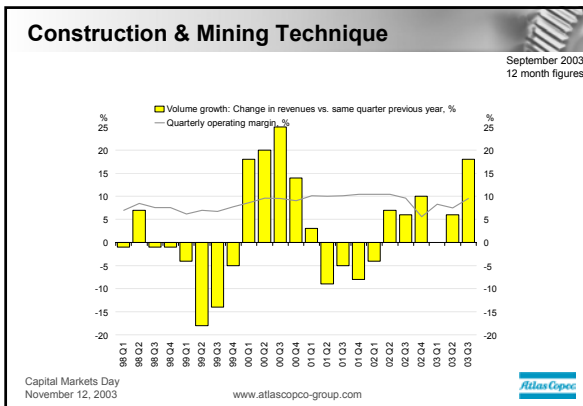
- Order volume growth, +8%

- Acquisition of Chinese rock drilling equipment manufacturer

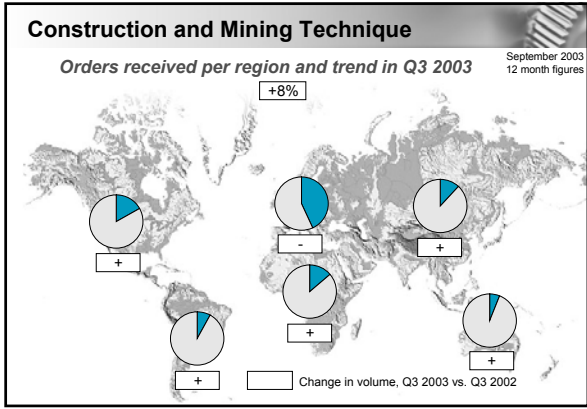
